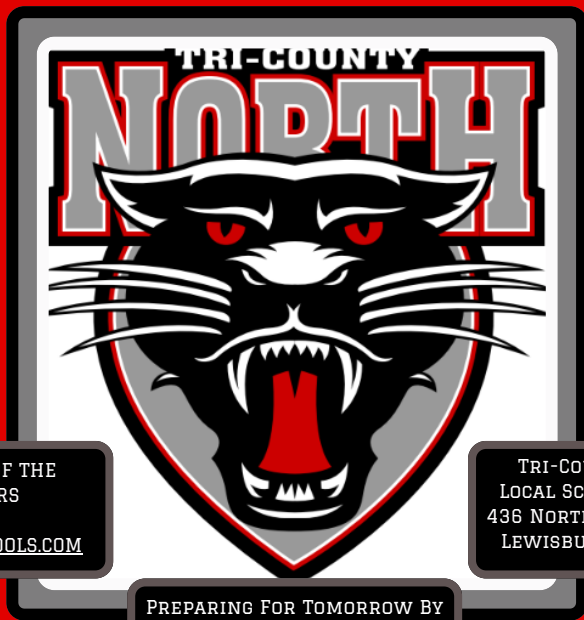

THE TRI-COUNTY NORTH LOCAL SCHOOL DISTRICT COMMUNITY ENCOMPASSES MOST OF THE NORTHEASTERN PORTION OF PREBLE COUNTY AND EXTENDS INTO SMALL SECTIONS OF DARKE AND MONTGOMERY COUNTIES. THE DISTRICT COVERS APPROXIMATELY 58 SQUARE MILES, INCLUDING THE VILLAGES OF LEWISBURG AND VERONA. FARMING AND MAJOR COMPANIES DOMINATE THE DISTRICT'S ECONOMY.
